Questions and Answers about Pre-Arranging and Pre-Payment

1. Q. What do you mean by “Pre-Arranging?”

A. Pre-arranging simply means that you sit down with one of our experienced Family Service Advisors and plan your service details in advance.

2. Q. Is that as unsettling an experience as it sounds?

A. Not at all. In fact, most people find that pre-arranging gives them peace of mind because they have taken the initiative to spare their families this duty at some future time when it would, indeed, be a disturbing task.

3. Q. How does it work?

A. Our Family Service Advisors record your personal instructions as to the type of service you want, (burial, cremation) the merchandise you select, the amount to be spent and other details. This information is kept on file at the Funeral Home until it is needed.

4. Q. Why should I consider pre-arrangements?

A. In some cases, surviving family members make emotional decisions in their time of bereavement that result in spending more on services and merchandise than the deceased would consider wise. By arranging the details of the service in advance you can prevent such emotional overspending. And if you pay for the service in advance utilizing our State Regulated Trust Account, you can “freeze the cost” at today's prices.

5. Q. What do you mean “freeze the cost?”

A. Inflation is pushing costs up-ward just like everything else. But if you pay for your pre-arranged service in advance, you are guaranteed that the services, the type of casket or urn and all other components you have selected will be supplied at the prices prevailing today, not an inflated future price.

6. Q. How do I do that?

A. Once you decide the type of services and merchandise you want, a contract is established in your name. Then you pay either in a lump sum or installments extending over a reasonable period to suit your needs. Your money remains in trust in a regulated bank.

7. Q. Is this plan regulated by any governmental agency?

A. Copies of all Osceola Memory Gardens pre-need trust instruments and pre-need agreements have been filed with the Comptroller Office, Department of Banking and Finance as a public record. Periodically they are required by law to audit our records insuring proper handling of your money.

8. Q. The plan sounds solid enough, but I have life insurance. Why should I have this trust account too?

A. Because your family will primarily use your life insurance benefits for their living expenses and perhaps for your final medical and other expenses. The trust account means that costs won't have to be taken from their income. And your life insurance policy cannot “freeze” the price from inflationary increases. It's really a matter of thoughtfulness as well as prudent financial management.

9. Q. Can I set up this trust for anyone in my family?

A. Yes, there's no limit as to the number of family members who can join the trust. A separate contract will be set up for each member who enrolls.

10. Q. Where can I get more specific information about this plan?

A. You can call us and one of our Family Service Advisors will arrange an appointment for you at your convenience in our offices or your home.

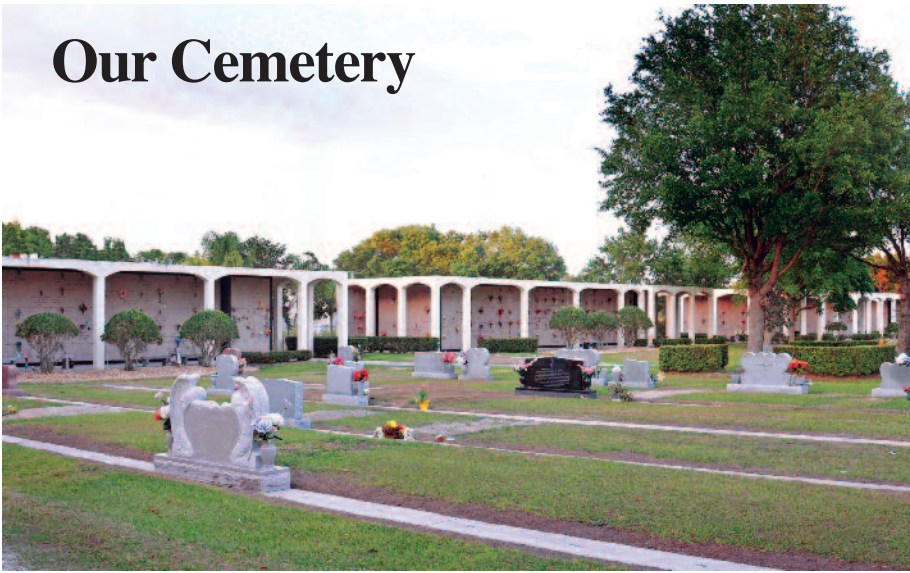
